# Making a Gift in Your Will to St Sava

Including a gift in your Will is perhaps the most personal commitment you can make towards the future of our next generation. Regardless of the amount given, St Sava College values every gift. Once you have completed the arrangements for your gift, we ask that you inform us that you have done so. This enables us to thank you and to keep you aware of the activities at St Sava.

## Gift wording

We strongly recommend that you consult with your lawyer before preparing a new Will or adding to an existing one (codicil). Whilst St Sava College cannot provide specific advice on estate planning, we do encourage you to communicate your intention to your family or other beneficiaries. As a starting point, we suggest that you use the following wording to make a gift to St Sava College. ## For a gift from Residue

'I give \_\_\_\_% of the residue of my estate to The St Sava College Limited ABN 12345667 for the general purposes of that Trust and the receipt of the Chairman, treasurer or other proper officer of The Sava College Board is an absolute discharge to my executors.'

## For a Money gift

'I give \$\_\_\_\_\_ to St Sava College Limited ABN 1234567\* for the general purposes of that Trust and the receipt of the Chairman, treasurer or other proper officer of St Sava College Limited is an absolute discharge to my executors.'

## For an Index-Linked Money gift

'I give the sum of money produced by dividing the sum of \$\_\_\_\_\_ by the index figure in the All Groups Consumer Price Index for Sydney ('the Index') for the quarter in which this Will is signed and (having made allowance for any re-basing of the Index which may have happened in the meantime) multiplying it by the index figure in the Index for the quarter in which my death occurs to The St Sava Limited as trustee of St Sava Building Trust ABN 1234567\* for the general purposes of that Trust and the receipt of the Chairman, treasurer or other proper officer of St Sava College Limited is an absolute discharge to my executors.' \*Please choose The Building Trust.
